Purpose for which we treat your personal data

In SLEEP STAR ONE, S.L. we treat the information provided by interested persons in order to manage all the accommodation reservations made through this website as well as to send promotional communications that are offered by us.

How long do we treat your personal data?

The data provided will be kept throughout the term of the contractual relationship signed between the parties, as well as during the term established by the Law in order to meet those responsibilities that may arise from the contractual relationship subscribed with SLEEP STAR ONE, SL, after which they will be blocked.

Legitimation for the treatment of your personal data.

The legal basis for the processing of your data is the consent given for the development and fulfillment of the management of the accommodation reservations.

The sending of information and promotional communications of the company that SLEEP STAR ONE, S.L. offers, finds its legal basis in its legitimate interest, being able to express the client at any time its opposition to this type of treatment. The use of this right will not, in any case, condition the termination or impede the adequate fulfillment of the management of the hosting service.

Categories and types of data treated

The categories of data that are treated are:

- Identification data (name and surnames).
- Postal or electronic addresses.
- Phone number.

Specially protected personal data is not treated.

To which recipients will your personal data be communicated?

No data will be transferred to third parties, except if there was a legal obligation to do so.

What are your rights when you provide us with your personal information?

Anyone has the right to obtain confirmation on whether SLEEP STAR ONE, S.L. is processing personal data that concerns them.

The interested party will have the right to withdraw their consent at any time, as long as the treatment is not necessary for the fulfillment of a contract. The withdrawal of consent will not affect the legality of the treatment based on the consent prior to its withdrawal.

Interested persons have the right to access their personal data, as well as to request the rectification of inaccurate data or, where appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes that were collected. In certain circumstances, interested parties may request the limitation of the processing of their data, in which case we will only keep them for the exercise or defense of claims. In the same way, they may exercise their rights of opposition and portability.
